



## Guidelines for Reference Citations

---

In addition to providing a PDF of your presentation (from PowerPoint or Keynote), please provide a PDF of a separate compiled bibliography of all references cited in your presentation. Format should comply with the guidelines for references as specified in the AMA Manual of Style. Examples of reference types include:

### **Journal Article**

Specify authors' surnames and initials; article title and subtitle; abbreviated name of journal; year; volume number; issue number; part or supplement number (if indicated); inclusive page numbers; digital object identifier (DOI) (if given).

#### Example:

Gou H, Fan R, Chen X, Li L, Wang X, Xu Y, Svensson P, Wang K. Adjunctive effects of laser therapy on somatosensory function and vasomotor regulation of periodontal tissues in patients with periodontitis: A randomized controlled clinical trial. *J Periodontol*. 2020 Oct;91(10):1307-1317. doi: 10.1002/JPER.19-0562.

### **Book and Book Chapter**

Specify authors' surnames and first and middle initials; chapter title, when cited; surname and first and middle initials of book authors or editors; title and subtitle of book; volume number and volume title (if any); edition number; place of publication; name of publisher; year of copyright; page numbers.

#### Example:

Shaffer JR, Weyant RJ. Oral-systemic health: The genomic connection. Chapter 14 in: Glick M, ed. *The Oral-Systemic Health Connection*. 2nd ed. Batavia, IL: Quintessence Publishing; 2019:292-310.

### **Conference Presentation**

Specify authors' surnames and initials; presentation title and subtitle; conference name; conference date; conference location; abstract number (if given). If online, include URL and accessed date.

Example:

Ruan C. Immunomodulatory activity seen as a result of photobiomodulation therapy in stimulated primary periodontal ligament fibroblasts. Academy of Laser Dentistry 26th Annual Conference; April 3-6, 2019; Dallas, TX.



## Guidelines for Reference Citations

---

### **Government or Agency Bulletin**

Specify name of author (if given); title of bulletin; place of publication; name of issuing agency; publication date; page numbers (if specified); publication number (if any); series number (if given).

#### Example:

U.S. Department of Health and Human Services. Oral Health in America: A Report of the Surgeon General. Rockville, MD: U.S. Department of Health and Human Services, National Institute of Dental and Craniofacial Research, National Institutes of Health, 2000.

### **Web Site**

Specify author (if given); title (if none given, specify the organization name responsible for the site); name of Web site; URL; published date; updated date; accessed date.

#### Example:

Evidence. ADA Center for Evidence-Based Dentistry. <https://ebd.ada.org/en/evidence>. 2021. Accessed February 13, 2021.

### **Social Media**

Specify title; organization name; accessed date; URL.

#### Example of YouTube video:

The Connection Between Diabetes and Periodontitis. UMichDent. YouTube page. Accessed February 13, 2021. <https://www.youtube.com/watch?v=8s5a73Ccy7Y>.
